

## Official Masters Athlete Refund Policy Maccabi USA has set the following refund policy for the 15<sup>th</sup> Pan American Maccabi Games:

## **Official Refund Policy**

1. Money raised through the sale of Raffle Tickets is **<u>non-refundable under any</u>** <u>**circumstances.**</u>

2. Money raised through the sale of Raffle Tickets is **<u>not tax-deductible</u>** (per IRS regulations).

3. Money raised through the sale of Raffle Tickets will be credited towards the team member's financial commitment at a rate of \$80 for each \$100 Raffle Ticket sold.

4. Money contributed <u>personally</u> by a Team member who has participated in the Games which exceeds their financial commitment may be refunded after the competition if a formal written request is given to Maccabi USA within 30 days of return from the Games. Alternatively, any overage of funds may be applied to another USA Team member or to the general 15<sup>th</sup> Pan American Maccabi Games funds.

5. The financial commitment for athletes in the U16, U18, Open and Para categories is \$6,650. Payments or fundraising directed towards an athlete's personal financial commitment are <u>not tax-deductible</u> as the athlete is receiving a benefit. Please contact the office for more information. Tax deductible charitable contributions may be made to the organization (general scholarship fund, sport or team) so long as they are not designated to support a specific athlete's financial commitment to participate. Please consult with your tax advisor.

6. **If Maccabi USA drops** a team from the competition, money raised or contributed personally by the team member, or others on behalf of the team member, will be refunded.

7. **If a member of the USA delegation withdraws** from the Team for any reason and the respective sport is still taking place in the Games, money contributed personally by the Team member, or others on behalf of the team member, will be refunded according to the following schedule listed below.

Maccabi USA will keep the following non-refundable amount

```
$360 before July 1, 2023
$2,000 before August 15, 2023
$4,000 before October 1, 2023
```

## If a member of the USA delegation withdraws after October 1, 2023 no refund will be issued.

No refunds will be given for any Raffle Ticket contributions.

8. If an airline ticket has been issued and not used, the **Airline Ticket** issued in the name of the Team member **may** be used for future travel if allowed by the airline contract and regulations.

9. All participants are strongly encouraged to purchase Travel Insurance for your trip. A "Cancel for any Reason" policy is suggested to protect participants in the event of injury or illness that may prevent one form participating. Travel Insurance policies typically require purchase **within 14-days of deposit** for the Games. It is the responsibility of the Team member to purchase travel insurance.
